



# **Yorkshire R.F.U**

## **Disciplinary Hearing**

A Yorkshire RFU Ltd Disciplinary Committee meeting at Express by Holiday Inn, Oulton, Leeds on January 23<sup>rd</sup> 2012 heard the following cases:

1. Richard Gordon, of Roundhegians RUFC, who was sent off for punching, contrary to law MR10 (4) (a), on December 3<sup>rd</sup> 2011, was suspended for 4 weeks and can resume playing on the 24<sup>th</sup> January 2012.
2. Lee Johnson, of Roundhegians RUFC, who was sent off for a dangerous tackle, contrary to law MR10 (4) (g) on December 3<sup>rd</sup> 2011, was suspended for 5 weeks and can resume playing on the 31<sup>st</sup> January 2012.
3. Jamie Fletcher, of Leeds Corinthians RUFC, who was sent off for stamping, contrary to law LE10 (4) (b) on January 7<sup>th</sup> 2012, was suspended for 2 weeks and can resume playing on the 7<sup>th</sup> February 2012.
4. Peter Woolley, of Malton & Norton RUFC, who was sent off for verbal abuse of the referee, contrary to law MR10 (4) (s) on January 7<sup>th</sup>, was suspended for 9 weeks and can resume playing on the 13<sup>th</sup> March 2012.
5. James Krebs, of Hullensians RUFC, who was sent off for verbal abuse of the referee, contrary to law LE10 (4) (s) on January 7<sup>th</sup> 2012, was suspended for 5 weeks and can resume playing on the 14<sup>th</sup> February 2012.
6. Simon Bunting, of Sheffield Tigers RUFC was suspended from all activities related to Rugby Union until he appears.

Hull Ionians RUFC – Hull Ionians were severely reprimanded for allowing a breach of Regulation 15.1.2 to occur during the 2011 – 2012 season.

The coaches Richard Painter and Miles Kirk were severely reprimanded for allowing a breach of Regulation 15.1.2 to occur and continue. Hull Ionians RUFC must ensure the Coaches and Managers of Mini/Junior teams are aware of any Rules and Regulations concerning their teams. Hull Ionians RUFC must provide the Yorkshire Disciplinary Committee with details of how this is to be carried out.

Hull Ionians RUFC must put up notices in their Clubhouse stating that Hull Ionians RUFC had pleaded guilty to a breach of Regulation 15.1.2. That they had appeared before the Yorkshire Disciplinary Committee and been severely reprimanded. Copy of notice to be sent to Yorkshire Disciplinary Committee.
