Disciplinary Hearing

A Yorkshire RFU Ltd Disciplinary Committee meeting at Express by Holiday Inn, Oulton, Leeds on September 19th 2011 heard the following cases:

1. Mark Thomas, of Hornsea RUFC, who was sent off for 2 yellow cards, contrary to law LE10 (4) (m) on February 19th 2011, sending off sufficient.
2. Anthony Barratt, of Wath upon Dearne RUFC, who was sent off for punching, contrary to law LE10 (4) (a) on July 17th 2011, was suspended for 2 weeks and can resume playing on the 11th September 2011.
3. Matthew Ayres, of Hessle RUFC, who was sent off for 2 yellow cards, contrary to law TE10 (4) (m) on September 3rd 2011, was suspended for 2 weeks and can resume playing on the 4th October 2011.
4. Andrew Townend, of Pontefract RUFC, who was sent off for punching, contrary to law MR10 (4) (a) on September 3rd 2011, was suspended for 5 weeks and can resume playing on the 11th October 2011.
5. Paul Brennan, of Sandal RUFC, who was sent off for verbal abuse of the referee, contrary to law LE10 (4) (s) on September 3rd 2011, was suspended for 4 weeks and can resume playing on the 4th October 2011.
6. Andrew Mosby, of Stanley Rodillians RUFC, who was sent off for verbal abuse of the referee, contrary to law LE10 (4) (s) on September 3rd 2011, was suspended for 4 weeks and can resume playing on the 4th October 2011.
7. Mike Melhuish of Hessle (Hull Ionians) RUFC, who was sent off for verbal abuse of the referee, contrary to law LE10 (4) (s) on

November 20th 2010, was suspended for 6 weeks and can resume playing on the 15th January 2011.

8. Harry Challenor, of Redcar RUFC, who was sent off for stamping, contrary to law MR10 (4) (b) on August 27th 2011, was suspended for 3 weeks and can resume playing on the 11th October 2011.
9. Goran Jelenik, of Beverley RUFC, who was sent off for punching, contrary to law LE10 (4) (a) on August 19th 2011, was suspended for 2 weeks and can resume playing on the 4th September 2011.
10. Niall Murphy, of Huddersfield YMCA RUFC, who was sent off for a punching, contrary to law LE10 (4) (a) on July 17th 2011, was suspended for 2 weeks and can resume playing on the 4th October 2011.
11. Mario Ellison, of Hullensians RUFC, who was sent off for punching, contrary to law TE10 (4) (a) on April 16th 2011, was suspended for 8 weeks and can resume playing on the 4th October 2011.
12. Danny Adams, of Castleford RUFC, who was sent off for verbal abuse of the referee, contrary to law MR10 (4) (s) on February 26th 2011, was suspended for 10 weeks and can resume playing on the 30th August 2011.

Rawmarsh RUFC – 5.12 incident – playing an underage player in an adult match. Sanction – Deduction of 20 league points. Sanction suspended until April 30th 2012. Sanction to lapse provided no further 5.12 incidents occur.
